- 6. DAL Parliamentarian Report. SMSgt Anderson. No update. (CLOSED)
- 7. TEC Liaison Report. CMSgt Damrow. Not present. CMSgt Schulz gave an update. (CLOSED)
  - a. Open discussion on upgrading the obelisk footstone with Colonel Morrisey's date of passing. SMSgt Anderson made a motion to engrave Colonel Morrisey's date of passing from the gift shop funds/seconded by CMSgt Uthe. The vote called; approved.

- 10. EMPE Commandant Report. CMSgt Butts. (CLOSED)
  - a. CMSgt Butts introduced himself to the board of directors.
  - b. Colonel Tapia and he make a great team. They are participating in the ANG state partnership networking the capacity of international students to attend the NCO Academy.
  - c. Colonel Schlussel, the new Commander of the Barnes Center is full speed on EMPE.
  - d. There was very little interest in the Air Force for attending in-resident NCO Academy. Only two NCO Academy classes for the entire Air Force. Both classes were large; 24-1 and 24-2 were conducted at the Chief Master Sergeant Paul H. Lankford Enlisted Profession Military Education Center.
  - e. Colonel Schlussel was very impressed that the Chief Master Sergeant Paul H. Lankford Enlisted Profession Military Education Center conducting reveille and retreat every day. Students are required to wear blues to class, plus participate in organized physical training. No other AF NCO Academy's require students to participate in. As of 1 May 2024, all NCO Academies will meet more stringent requirements. The Chief Master Sergeant Paul H. Lankford Enlisted Profession Military Education Center is considered the Flag Ship for EMPE standards.
- 11. Past President Council Report. VACANT CMSgt Schulz. (CLOSED)
  - a. Still no volunteer to preside over the council.
  - b. Open discussion about whether the council is needed. Has not been active since March 2022.

- c. MSgt Oster made a motion to dissolve the council/seconded by SMSgt Anderson. The vote called; approved.
